4. The action was commenced on October 13, 2014, by the filing of a summons and complaint in Supreme Court, Nassau County. Defendants duly appeared by serving an answer on or about April 27, 2015.

- 5. Thereafter, a preliminary conference was held on November 20, 2015, and discovery exchanged.
- The parties exchanged document discovery and the depositions were completed.
   A Note of Issue was filed on August 17, 2016.
- 7. On October 3, 2017, the attorney for the defendants, William DeCandido, Esq, defendant Aaron Kapner, your affirmant on behalf of plaintiff, and Plaintiff Patricia Dubanos appeared in Court and reached a Stipulation of Settlement, So Ordered by the Court (the "Settlement & Order"). See Exhibit 1.
